(plans established<sup>1</sup> before 09/25/2007 and with no transfers-in after this date)

<b>Transferring 403(b) to a 403(b), QP, or IRA at successor custodian</b>	Completed successor custodian’s transfer paperwork signed and dated by participant and employer/approved provider. If transfer form does not allow for employer/approved provider authorization, either may just sign the transfer form in addition to the participant. Or attach a letter of authorization from the releasing employer/approved provider – sample can be obtained from TCA by E*TRADE.	Completed successor custodian’s transfer paperwork signed and dated by participant

<sup>1</sup>This refers to the plan’s establishment date - not the open date at TCA by E\*TRADE. However, any transfer into the account after 9/24/2007 will cause it to lose its “grandfathered” status and it will be subject to the new regulations.

<sup>2</sup> Reregistration of securities from a 403(b) plan is very rare. If securities are to be reregistered internally to a TCA by E\*TRADE IRA, attach such information to the 403(b)/457 Distribution Request under separate cover.

## Subject to New 2007 403(b) Rules

(plans established on or after 09/25/2007 or those with transfers-in on or after that date)

To accomplish	Regardless of participant's age
<b>Distribution to Account Owner – Cash (or internal transfer to an IRA at TCA by E*TRADE)</b>	Completed <b>403(b)/457 Distribution Request</b> form signed and dated by participant and employer (or approved provider)
<b>Distribution to Account Owner – Securities (or internal<sup>2</sup> transfer to an IRA at TCA by E*TRADE)</b>	Completed <b>403(b)/457 Distribution Request</b> form signed and dated by participant and employer (or approved provider)
<b>Transferring 403(b) to a 403(b), QP, or IRA at successor custodian</b>	Completed successor custodian's transfer paperwork signed and dated by participant and employer/approved provider. If transfer form does not allow for employer/approved provider authorization, either may just sign the transfer form in addition to the participant. Or attach a letter of authorization from the releasing employer/approved provider – sample can be obtained from TCA by E*TRADE.

<sup>2</sup> Reregistration of securities from a 403(b) plan is very rare. If securities are to be reregistered internally to a TCA by E\*TRADE IRA, attach such information to the 403(b)/457 Distribution Request under separate cover.
